COOLING-OFF PERIOD

Pursuant to BSP Circular No. 857, the TRUSTOR (individual participants) shall have the right to cancel their initial subscriptions or contributions, without penalty, upon written notice to the Trustee within two (2) banking days immediately following the signing of agreement or contract evidencing their participation in the Fund. Further, the net amount of payment or delivery due the TRUSTOR shall be based on the transaction day's NAVPU when notice of redemption, termination or cancellation was received.

INVESTMENT OBJECTIVE AND STRATEGY

The Fund is a Peso-denominated balanced Unit Investment Trust Fund that aims to achieve for its participants, growth and high income from a portfolio of diversified, blue-chip and fundamentally sound equities listed at the Philippine Stock Exchange (PSE) and peso-denominated fixed income securities. The Fund may invest between 40% and 60% of its market value in equities listed in Philippine Stock Exchange and a minimum of 40% of its market value in peso-denominated fixed income securities. The Fund's composite benchmark is composed of 60% Philippine Stock Exchange Index and 40% Markit iBoxx ALBI Philippines 1-5.

CLIENT SUITABILITY

A client profiling process is performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are encouraged to update the resulting profile every three (3) years or if there's any change in his/her personal/financial circumstances. Before deciding to invest, clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, or seek an independent/professional opinion when necessary.

The METRO BALANCED FUND is suitable only for investors who:

- Have an Aggressive profile.
- Want capital growth over the long-term and are willing to be exposed to a higher level of risk that may involve possible loss of principal in the short-term in exchange for higher long-term gains.
- Recommended investment horizon is at least five (5) years
- Participation in the Fund shall be open to Filipino individuals, resident and non-resident aliens and corporate accounts.

KEY RISKS AND RISK MANAGEMENT

You should not invest in this Fund if you do not understand or are not comfortable with the accompanying risks.

Interest Rate Risk:	The possibility for an investor to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
Market/Price Risk:	The possibility for an investor to experience losses due to changes in the market prices of bonds and stocks/equities. It refers to the portfolio's exposure to marked-to-market valuation due to market price fluctuations of the bonds and stocks/equities.

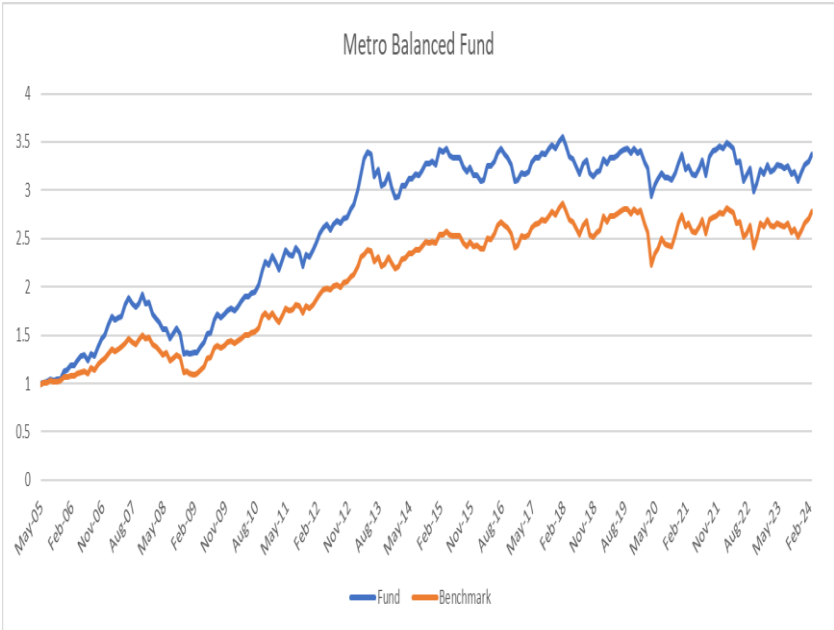

⁵ Benchmark return was based on the original benchmark of 50% 91-day Tbill and 50% Philippine Stock Exchange Index (PSEi) since inception, and was changed to 50% 91-day PDST-F and 50% PSEi from June 1, 2007 to August 31, 2010 then 60% PSEi and 40% HSBC Local Currency Bond Index (HSLI) 1-5 years (net of taxes) from September 1, 2010 to April 30, 2016 then 40% HSLI 1-5 years (net of taxes) was changed to 40% Bloomberg Philippine Sovereign Bond Index 1-5 year (BPHIL15) Adjusted, effective May 2016.

The BPHIL15-Adjusted Index was tentatively discontinued when the GS pricing basis shifted from PDST -R2 of PDEX to BVAL of Bloomberg effective October 29, 2018. The Fund used, an equivalent benchmark namely, the BPI Philippine Government Bond 1-5 Year Index (from October 30, 2018 to December 31, 2019) and Markit iBoxx ALBI Philippines 1-5 (from January 2020 until October 20, 2020). Effective October 21, 2020 the Fund benchmark is 60% Philippine Stock Exchange Index (PSEi) and 40% Markit iBoxx ALBI Philippines 1-5.

INVESTMENT POLICY

The Fund may be invested and reinvested in the following instruments:

- Equities listed in the PSE
- Fixed Income Instruments and Securities
- Deposits
- Other investments allowed under BSP regulations

OUTLOOK AND STRATEGY

Since bottoming out in October 2023, the PSEI has been on a steady uptrend, rallying +4.5% MoM to close at 6,944.71 in February, pushing the index up +7.7% YTD. This upward movement was fueled by improving macroeconomic indicators domestically, stable corporate earnings releases, and robust foreign inflows. Notably, the banking (+8.6% MoM) and industrials (+8.6%) sectors led the gains, while properties (-2.7%) and mining (-8.0%) ended in the red. ICT emerged as the top index gainer primarily due to foreign inflows and anticipation of strong core earnings results. Average volume turnover for the month stayed tepid at P5.2bn as investors lacked conviction beyond 7,000. On the flipside, foreigners were consistently buyers in the local equities market by USD129mn, extending their buying streak to 4 months.

In terms of corporate earnings, most of the nine PCOMP index constituents that reported 2023 full-year earnings met market expectations. However, SCC lagged estimates due to lower average selling prices despite improved coal sales in 4Q23. Banks, particularly BDO, BPI, and MBT, reported robust earnings, benefiting from the high-interest rate environment in the previous year. MBT surprised with a larger dividend payout, translating to an 8% dividend yield. Property companies also showed improvement, with ALI driven by better property development revenues while SMPH was lifted by its mall segment.

On the macroeconomic front, the BSP maintained its policy rates unchanged in its first Monetary Board meeting for 2024. The BSP slightly adjusted its inflation estimates, signaling the need to keep monetary policy tight to anchor inflation expectations amid various risks, including geopolitical tensions, higher rice and electricity prices due to El Nino, and increased gasoline prices. On that note, February's inflation print surpassed expectations, at 3.4% YoY versus 3.0% market consensus and January's print of 2.8%, driven by a significant increase in rice inflation, the fastest in 15 years.

On the fixed income space, the BTr announced five T-Bond auctions, including 3-year, 5-year, 7-year, 10-year, and 20-year issuances. However, the BTr cancelled three auctions (5-year, 7-year, and 10-year) to accommodate the offer period of the new 5-year RTB. Only the 3-year re-issuance of FXT3-30 and the new 20-year FXT2026 were auctioned for the month. Surprisingly, the BTr awarded the new 20-year FXT2026 coupon at 6.25%, the same rate as the coupon of the new 5-year RTB5-18. The tendered bids received for the new 20-year issuance amounted to PhP91.423 billion, making it 3.05 times oversubscribed. Yields across the curve were higher by an average of 15 bps MoM. Both the 20-year and 25-year BVAL rates increased by an average of 19 bps MoM, reaching 6.31% compared to the previous month's BVAL of 6.12%. In March, the BTr plans to sell government securities aiming to raise PhP180 billion. The T-Bond issuances will have revised tenors of 7 years, 10 years, 20 years, and 6 years, differing from the original advisory of 3 years, 5 years, 7 years, and 10 years. The BTr attributed the revised tenors to the outcome of the new 5-year RTB offering. For the balanced funds, the strategy of maintaining overweight duration compared to the benchmark and keeping cash at a minimum was also upheld.

The Philippine economy's stable growth, disinflation outlook, and potential 2024 policy easing offer an optimistic investment landscape. We project corporate earnings to grow by 6% in 2024, considering a 13x PE for FY2024, which puts our FY2024 PSEI target at 7,400.
